RELEASE OF LIABILITY

(Must be signed by a parent or by legal guardian, and may not be altered)

As parent(s) or legal guardian of the above camper, the camper has my/our permission to participate in all Camp activities this summer, without limitation. On behalf of myself/both of us, the camper, and the camper's minor siblings, I/we hereby release and hold harmless Camp Micah and its members, managers, directors, agents, insurers, volunteers, employees and representatives from any and all claims resulting from physical injury or property damage sustained in connection with the camper's participation in any Camp activities.

Camp Micah may use any individual or group photographs, written comments, video and/or audio recordings, taken at Camp Micah or elsewhere, documenting a Camper in-camp activities, for the purpose of promoting camper enrollment and/or advertising the Camp, including, without limitation, on the Camp Micah website.

The internal laws of the State of Maine shall govern all matters relating in any way to the camper's enrollment as a camper, including participation in Camp activities and this application and agreement, and exclusive jurisdiction and venue for any litigation shall be in Cumberland County, Maine.

The inclusive tuition of the Full Session is \$10,000. The inclusive tuition for the First or Second Session is \$6050. The inclusive tuition for the 2-Week Taste of Micah is \$4000. An additional transportation fee of \$200 for full season campers and \$150 for single session campers will be added to your bill. There are no gratuities allowed. Any child cancelling between September 1 and November 30 will receive a refund minus \$500.00. This is a non-refundable registration fee, which covers the basic administrative cost of the enrollment. From December 1 to January 30 you will receive a refund minus \$1000. After February 1, no money will be refunded. There can be no exceptions.

If you do not pay the tuition in accordance with this Application for Membership or other payment terms as set forth by Camp Micah, you will be in default. If you are in default of payment under this Application for Membership or other payment terms as set forth by Camp Micah, Camp Micah at its sole election shall have the right to exercise any and all its rights to collect the tuition. You will be responsible for all costs of collection and costs of enforcing its rights under the Application for Membership, including but not limited to, reasonable attorneys' fees and court costs. All tuition or other payments chargeable under this Application for Membership or as set forth by Camp Micah shall be payable in full and not subject to reduction on any basis. This payment default provision shall be governed by and subject to the laws and decisions of the State of Maine. You agree that any action arising out of or in connection with this payment default provision may be commenced in a local, state or federal court located in Cumberland County, Maine or any other court selected by Camp Micah where it maintains a place of business. You hereby irrevocably consent to the jurisdiction and venue of any such court and waive any objection relating to improper venue or forum non conveniens to the conduct and proceeding in any such court. You expressly waive any right to a trial by jury.
